At present, he is working on critical commentaries on recent developments in constitutional rights adjudication in Malaysia and Singapore. Benjamin also has a secondary interest in criminal procedure in Singapore; in 2021, he appeared before the High Court as amicus curiae in *Parti Liyani v Public Prosecutor* to make submissions on compensation for allegedly frivolous or vexatious prosecution.
